Research Chemicals — For Research Use Only

1. Acceptance of Terms

By accessing, browsing, or placing an order on the Monkey Mog website (the "Site"), you acknowledge that you have read, understood, and agree to be bound by these Terms and Conditions ("Terms") in their entirety. If you do not agree with any portion of these Terms, you must immediately discontinue use of the Site and refrain from placing any orders. These Terms constitute a legally binding agreement between you ("Customer," "User," or "Buyer") and Monkey Mog ("we," "us," or "our").

2. Nature of Products — Research Use Only
